Catch-n-Fetch assumes no liability for loss or damage from disease, sickness, before, during or after, death, running away, theft, fire, injury to persons, other pets or property by this pet or other unavoidable causes, due diligence and care having been exercised. I hereby release them of any liability whatsoever and I further agree to indemnify and save them harmless against any and all claims arising from my pet's attendance and participation at Catch-n-Fetch, including but not limited to, all costs, attorneys fees, expenses and liabilities in connection therewith.
